## Re: Abuse and Neglect in For-Profit Child Care Centres

Congratulations on your appointment as Minister for Early Childhood Education in the newly elected Albanese Government.

I am writing to you on behalf of Zonta Australia which provides a framework for a collective voice for the three Zonta International Districts in Australia. Zonta International is an international human rights organisation committed to advancing the status of women and girls worldwide, particularly in the areas of leadership, advocacy, education and empowerment. Zonta Australia engages in advocacy at a national level on behalf of 102 clubs and approximately 2,275 members across Australia.

It is with deep concern that we note the recent allegations of child abuse and neglect in some commercial for-profit child care centres, aired in the Four Corners program Betrayal of Trust in March this year, and subsequently aired in a condensed form on the 7.30 Report on 7 April 2025. Other reports echo these reports.

Recent reports also reveal that 95% of the 300 - 400 new child care centres opened each year are for-profit. Apart from one of the top 10 largest operators, the remainder are controlled by private equity firms and international investment groups, all driven by profit rather than child welfare.

Professor Gabrielle Meagher, Professor Emerita School of Social Science Macquarie University, is a leading expert on privatised social services. She points to the "overwhelming evidence showing that for-profit providers deliver lower-quality services on average compared with their non-profit equivalents. For investors, the childcare sector is an attractive opportunity, thanks to billions of dollars in government subsidies and grants underwriting the business. The whole industry is massively underpinned by a secure and growing stream of government income".

An Australian Competition and Consumer Commission (ACCC) report from December 2023 found that for-profit providers paid lower wages and hired less-experienced staff than their non-profit equivalents, leading to a decline in the quality of standards.

Zonta Australia believes that the national regulator and state investigating authorities should be resourced to investigate these claims and that any findings should be made available to the general public.

Furthermore, we believe it is the expectation of Australian women and men that governments must play a central role in setting up and maintaining standards of care for its most vulnerable members; in particular the very young and the very old. We urge both the Federal Government and state governments to address these allegations in a transparent manner as soon as possible.

We recognise that child care in Australia is regulated by national laws and regulations legislated by the Commonwealth Government in the National Quality Framework. The National Quality Standards set a benchmark for early childhood education with seven quality areas to ensure child care is safe, healthy and effective. We also recognise that the States and Territories are responsible for monitoring, assessing and supervising approved providers and services.

While we note that the Federal Government has committed to building new child care centres in areas of need, we recommend that they be community-based child care centres, staffed by qualified child care educators, to serve as models of good practice and to give parents some choice in choosing a good centre. At this point in time parents have very few options in finding a place for their child and end up taking any offer they can find so they can take up paid employment.

We agree with three proposals being suggested to improve the quality and safety of Australia's child care centres:

- 1. Design safer centres
- 2. Conduct a thorough review. We wonder if the National Child Safety Review announced by the Australian Department of Education on 29 April 2025 during the caretaker period is going to proceed
- 3. Increase the status of early childhood education in Australia.

Zonta Australia has three specific requests of the Australian Government:

- 1. A commitment that the National Child Safety Review proceeds.
- 2. Details be released on how the new proposed centres will be built and staffed.
- 3. Clarity on the matters we have raised so we can reassure our members across Australia that action will be taken to rectify the current situation and that appropriate guidelines will be established for the new centres to be built by your Government.

I look forward to your considered response to the concerns and issues raised.
